

## Our Safety Showing Procedures During Covid-19 Outbreak



## For Buyers:

- 1. Prior to touring a home all buyers are required to sign a PEAD form and forward it to the Listing Agent prior to entry. As your Buyer's Agent, I will forward the signed PEAD form to the Listing Agent as part of the appointment setting process. The PEAD form states:
  - a. You are not currently afflicted with, and have not knowingly, within the last 14 days, been in contact with someone afflicted with COVID-19; and
  - b. You are not experiencing a fever, or signs of respiratory illness such as cough, shortness of breath or difficulty breathing, or other COVID-19 symptoms
- 2. If your health condition or exposure to COVID changes at any time, you are required to notify Gary Nobile as soon as reasonably possible.
- 3. Prior to touring, all buyers will be requested to view the Virtual Video and Matterport tour, if available.
- **4.** Prior to touring, all buyers will be required to provide a Preapproval Letter and Proof of Funds. For your ID protection, be sure to eliminate account numbers from your document(s) prior to transmitting.
- 5. Prior to touring, all buyers will be requested to do a drive by of the property (at a minimum do a Google street view drive by).
- 6. Sellers are required to vacate the home before a buyer or buyer's agent may go inside.
- **7.** Prior to touring, buyers and agents will be required to take every precaution outlined in the PEAD, including:
  - a. Only 2 people from the same household at one time on the premises, plus either the Listing Agent or one Buyer's Agent
  - b. Maintain a social distance of 6 feet apart
  - c. Agents and Buyers are asked to wear gloves, booties and a mask or scarf to cover their faces.
  - d. Only agents may touch light switches or door handles.
  - e. No one is to use the bathrooms.
  - f. Agents are required to wipe off any door handles used and the lock box with disinfectant wipes.
  - g. Buyers and Agents will be required take any wipes, shoe covers and masks with them and to dispose of them.

## For Sellers:

- 1. Sellers will sign the PEAD form prior to any showing verifying:
  - a. They are not currently afflicted with, and have not knowingly, within the last 14 days, been in contact with someone afflicted with COVID-19; and
  - b. They are not experiencing a fever, or signs of respiratory illness such as cough, shortness of breath or difficulty breathing, or other COVID-19 symptoms; and
  - c. That they believe they are not likely to transmit or contract COVID-19.
- 2. If your health condition or exposure to COVID changes at any time, you are required to notify Gary Nobile as soon as reasonably possible.
- 3. Sellers and required to turn on light switches and to leave closet doors open.
- **4.** Seller must leave the property prior to any showings and may only return after the buyer and their agent have left.
- 5. Listing Agents are to provide shoes coverings, waste basket, disinfectants and paper towels.
- 6. After all showings, Seller is to clean and disinfect the Property, paying
